RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A DEED OF EXCHANGE WITH PUNONG BARANGAY ELMER TUVILLARA, AND TO SIGN OTHER RELATED DOCUMENTS FOR THE TRANSFER OF TITLE THEREFOR.

WHEREAS, the Municipality of Tigbauan has purchased a lot, Lot No. 8454-B to be utilized as the school site for Bagacay National High School located at Brgy. Bagacay, Tigbauan, Iloilo;

WHEREAS, the exact delineation of the property and its boundaries were only defined in the later part of 2017, after the construction of additional school buildings at Bagacay National High School;

WHEREAS, the new classrooms constructed in the later part of 2016 were discovered to have been constructed outside the lot purchased for the purpose, identified as Lot No. 8454-C-1, with an area of 1,375 sq. meters, owned by the family of Punong Barangay Elmer Tuvillara;

WHEREAS, the LGU Tigbauan obligates itself to enter into a deed of exchange of property with almost the same value with the Tuvillaras, to compensate the latter of the encroached property;

WHEREAS, LGUTigbauan identified Lot. No. 8454-B-3, a portion taken from its property, containing an area of 1,584 sq. meters, located at Brgy. Bagacay, Tigbauan, Iloilo, as the lot which must be exchanged with the Tuvillaras as a replacement;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in behalf of the Municipality of Tigbauan, to enter into a Deed of Exchange with Punong Barangay Elmer Tuvillara, and to sign other related documents for the transfer of title therefor.
