RESOLUTION DECLARING AS **LEGAL AND VALID** BARANGAY BARROC ORDINANCES NO. 2018-001 ENTITLED, **“AN ORDINANCE RENAMING “BANGGA SAMBAG ROAD” TO ALBINO TAVARRA TRIVILEGIO ROAD, BRGY. BARROC, TIGBAUAN, ILOILO** AND NO. 2018-002 ENTITLED, **“BRGY. ORDINANCE ON ILLEGAL TAPPING ON BARANGAY STREETLIGHT AND WATER SYSTEM”**, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the above-mentioned Barangay Ordinances were referred to this Committee for review and recommendation and the Committee has the following findings, to wit:

The said ordinances were accordingly presented in a barangay assembly and were consistent with the provisions of Section 391 of the Local Government Code, to wit:

SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;

(24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;

X X X”

WHEREAS, the same were also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

VIRGILIO T. TERUEL,)* and duly seconded by Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma and Hon. Dyossa Marie Teruñez;

RESOLVED, to declare as **Legal** and **Valid** Barangay Barroc Ordinances No. 2018-001 entitled, ***“An Ordinance Renaming “Bangga Sambag Road” to Albino Tavarra Trivilegio Road, Brgy. Barroc, Tigbauan, Iloilo”*** and No. 2018-002 entitled, ***“Brgy. Ordinance on Illegal Tapping on Barangay Streetlight and Water System”***, Municipality of Tigbauan, Province of Iloilo;
