RESOLUTION CONFORMING AND APPROVING THE CY 2018 SUPPLEMENTAL BUDGET OF BARANGAY DAPDAP, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on July 9, 2018 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2018 Supplemental Budget embodying Appropriation Ordinance of the following barangay:

**Brgy. Dapdap** Supplemental Budget No. 001-2018 for CY 2018, involving an Appropriation of P140,000.00 and was approved by the Sangguniang Barangay on June 30, 2018.
