RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY MIAG-AO (ISAT-U MIAG-AO), MIAG-AO, ILOILO FOR THE ON-THE-JOB TRAINING (OJT) PROGRAM FOR ITS STUDENTS.

WHEREAS, Iloilo Science and Technology University-Miag-ao (ISAT-U MIAG-AO) is a state university offering technical courses wherein its students are required to undergo on-the-job training program as an academic requirement prior to graduation in order to be adequately exposed to actual industrial work situation, thereby augmenting their formal schooling;

WHEREAS, LGU Tigbauan has the facilities and expertise to provide occupational experience to student-trainees to enhance their competence in their chosen fields of endeavor as part of its efforts to help in the community development and cultivate a pool of manpower from which the LGU may possibly recruit its needed personnel in the future;

WHEREAS, there will be no employer-employee relationship between the LGU and the student-trainees;

WHEREAS, the student-trainees will just have to abide by the LGU rules and regulations and comply with those imposed for the program;

WHEREAS, the program aims for the best interest of the students, especially so that they are mostly residents of the Municipality of Tigbauan.
