RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF THE GOOD GOVERNOR, HON. ARTHUR DEFENSOR, SR., PROVINCE OF ILOILO FOR THE CONSTRUCTION OF BAROSONG HANGING FOOTBRIDGE IN THE AMOUNT OF FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00).

WHEREAS, the construction of a hanging footbridge over the Sibalom River in Barangay Barosong is a long cherished dream of the residents of Barangays Barosong, Canabuan, and Isian, this municipality;

WHEREAS, said hanging footbridge would be a vital alternative passage for people in said areas, especially women and children, during rainy days when the Sibalom River overflows which seriously endangers lives and properties;

WHEREAS, the construction of this hanging footbridge would protect and promote the health and safety of the residents of said barangays, particularly their livelihood as it would enable them to bring their agricultural produce to the markets even during floods, thus supporting their economic activities;

WHEREAS, with the help of our good Governor, the Municipal Government of Tigbauan would finally realize this long cherished dream of a hanging footbridge in the area;
