RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH JOSE EDGAR G. GATON FOR THE PAYMENT OF MONTHLY ELECTRICAL BILLS AND WATER SUPPLY OF THE ALS COMMUNITY LEARNING CENTER.

WHEREAS, the ALS COMMUNITY LEARNING CENTER is the seat of Kaaram Sa Duyan Literacy Program of the LGU Tigbauan, located at Brgy. Buyu-an, Tigbauan, Iloilo;

WHEREAS, the center is made of temporary materials and does not have its own electrical and water supply, thus dependent on the accommodation of the Lot Owner, Mr. Edgar G. Gatón;

WHEREAS, the old Memorandum of Agreement with Mr. Gatón ended up only until the first phase of the implementation of Literacy Coordinating Council (LCC) assisted project, which was extended for three (3) more months;

WHEREAS, the amount of Six Hundred Pesos (P600.00) shall be paid for the electrical Bill and the amount of Three Hundred Pesos (P300.00) shall be paid for the water supply for 3 months.

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement (MOA) with Jose Edgar G. Gatón for the payment of monthly electrical bills and water supply of the ALS Community Learning Center.
