Resolution No. 2018-101

RESOLUTION INTERPOSING NO OBJECTION TO THE APPORTIONMENT OF A FIVE HUNDRED (500) SQUARE METER PORTION OF THE PUBLIC LAND LOCATED AT BARANGAY NAMOCON NEAR THE TIGBAUAN FIRE STATION FOR THE PHILIPPINE COAST GUARD AND WAIVING ALL RIGHTS AND INTERESTS THEREON IN FAVOR OF THE SAID GOVERNMENT AGENCY.

WHEREAS, the Local Chief Executive in a letter dated June 5, 2018 indorsed the letter of Coast Guard Station Iloilo, requesting for a partnership with the Local Government Unit of Tigbauan for the proposed construction of a two-storey Radar Station and Substation of the Philippine Coast Guard in this municipality;

WHEREAS, as stated in the said letter, the Philippine Coast Guard asked the support of the municipality in providing the locational site of its Sub-Station with an area of at least 500 square meters for the building, with provision for the slipway, boathouse, berthing space and Vessel Management System (VTMS);

WHEREAS, the primary purpose of this Vessel Management System (VTMS) is to improve the safety, efficiency of navigation and feature of port services, protection of life at sea and safeguard the marine environment;

WHEREAS, the Philippine Coast Guard is mandated and responsible to perform maritime search and rescue, maritime law enforcement, maritime safety, marine environment protection and maritime security;

WHEREAS, a Coast Guard permanent sub-station in every port or city will enable the Philippine Coast Guard to fulfill its mandate well and achieve its vision to become a world class guardian of the sea committed to save lives, ensure safe maritime transport, cleaner seas and secure maritime jurisdiction by 2028;

WHEREAS, after a series of meetings and lot inspections conducted by the LGU-Tigbauan, with the presence of Coast Guard Officials headed by Capt. Allan Victor T. dela Vega, *PCG, Acting Commander, CGDWV*, the Local Chief Executive requested the CENRO, Miag-ao Officials headed by Engr. Mary Julienne Bongal, *Engineer II* to conduct a survey of the Public Land located at Barangay Namocun, Tigbauan, Iloilo, near the Tigbauan Fire Station;

WHEREAS, the Coast Guard Officials considered the said area as an ideal location for the construction of the proposed project and vital in ensuring safe and orderly maritime travel;

WHEREAS, the Local Chief Executive in her letter dated August 14, 2018, urgently requested this August Body to pass a *“Resolution Interposing No Objection for the Apportionment of 500 square meters of a Portion of the Public Land located at Barangay Namocun (near Tigbauan Fire Station) for the Philippine Coast Guard and Waiving All Rights and Interests Thereof in Favor of the said Government Agency;*

WHEREAS, the Municipal Officials of the Local Government Unit of Tigbauan recognize the importance and necessity of availing of such project;


