**Resolution No. 2018-113**

RESOLUTION CONFORMING AND APPROVING THE CY 2018 SUPPLEMENTAL BUDGET OF BARANGAY **NAPNAPAN SUR**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 22, 2018 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached Barangay Napnapan Sur CY 2018 Supplemental Budget embodying Appropriation Ordinance, to wit:

*Brgy. Napnapan Sur Supplemental Budget No. 2018-001 for CY 2018, involving an Appropriation of P139,341.17 and was approved by the Sangguniang Barangay on July 13, 2018.*
