Resolution No. 2018-119

RESOLUTION GRANTING FINANCIAL ASSISTANCE TO AFFECTED FAMILIES BROUGHT ABOUT BY STORM SURGE DURING THE HEIGHT OF TYPHOON “OMPONG” IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) EACH FOR TOTALLY DAMAGED HOUSES AND THREE THOUSAND PESOS (P3,000.00) EACH FOR PARTIALLY DAMAGED HOUSES OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Local Chief Executive in a letter dated September 16, 2018 requested this Sangguniang Bayan for the urgent passage of “*Resolution Granting Financial Assistance to Affected Families Brought About by Storm Surge During the Height of Typhoon “Ompong” in the Amount of Five Thousand Pesos (P5,000.00) Each for Totally Damaged Houses and Three Thousand Pesos (P3,000.00) Each for Partially Damaged Houses of the Municipality of Tigbauan, Province of Iloilo*”;

WHEREAS, Typhoon “OMPONG” entered the Philippine Area of Responsibility (PAR) on September 12, 2018 at 3:00 o’clock in the afternoon;

WHEREAS, on September 15, 2018, the Southwest Monsoon (*Habagat*) was enhanced by Typhoon “OMPONG” which brought gusty winds with occasional moderate to heavy rains over Western Visayas;

WHEREAS, the Municipal Disaster Risk Reduction Management Office of the Municipality of Tigbauan tightened their monitoring of the movement of Typhoon OMPONG;

WHEREAS, after Typhoon OMPONG left PAR, the MDRRMO conducted a survey of the damaged brought about by storm surge in two (2) barangays along the coastal areas of the municipality and the following were the list of affected households:
