RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ACQUIRE/PURCHASE AN ADDITIONAL ONE (1) UNIT PATIENT TRANSPORT VEHICLE IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED THOUSAND PESOS (P1,800,000.00) FOR THE USE OF THE MUNICIPAL RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO), TIGBAUAN, ILOILO.

WHEREAS, the Municipality of Tigbauan has 52 barangays and with a total population of more or less 63,000 inhabitants;

WHEREAS, last 2014 the MDRRM Office purchased one (1) serviceable patient transport vehicle but this could not cater a 24/7 operation of the said office;

WHEREAS, based on reports, an average of 5 emergency calls per day mostly vehicular accidents transpires in the area of responsibility of this municipality;

WHEREAS, the increased awareness of the constituents towards health aspect and emergency cases caused a high demand for the availability of patient transport vehicle;

WHEREAS, in order to facilitate the efficient and effective delivery of services to our populace and to immediately respond to emergencies brought about by disasters, calamities and accidents, it is necessary for the MDRRMO to purchase an additional serviceable patient transport vehicle;

WHEREAS, the required funds for the acquisition of this patient transport vehicle has been appropriated as embodied in the CY 2018 Project Procurement Management Plan (PPMP) of the MDRRM Office chargeable against 5% MDRRM Fund (Preparedness Procurement);

WHEREAS, Memorandum Circular No. 2013-047 dated June 3, 2013, of the Department of Interior and Local Government (DILG) provided for the Guidelines on LGU's Acquisition of Motor Vehicles Pursuant to AO No. 15 S.2011;

WHEREAS, item No. 4.iii. of said DILG Memorandum Circular No. 2013-047 requires that acquisition of motor vehicles by LGU's should have a corresponding Local Ordinance/Resolution;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Peace & Order and Public Safety* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Acquire/Purchase an Additional One (1) Unit Patient Transport Vehicle in the Amount of One Million Eight Hundred Thousand Pesos (P1,800,000.00) for the Use of the Municipal Risk Reduction and Management Office (MDRRMO), Tigbauan, Iloilo;
