RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPALITY OF IGBARAS FOR THE TRANSFER OF FUNDS WORTH ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) AS CONTRIBUTION FOR THE FIRST CONGRESSIONAL DISTRICT SPORTS ASSOCIATION (FCDSA) MEET 2018

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991, **Section 99 (a)** provides that *“the Local School Board shall determine, in accordance with the criteria set by the Department of Education, Culture and Sports, the annual supplementary budgetary needs for the operation and maintenance of public schools within the province, city or municipality, as the case may be, and the supplementary local cost of meeting such as needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as this Code and other laws or ordinances may provide”*;

WHEREAS, each year, each municipality in the 1st Congressional District of Iloilo takes turn in hosting the First Congressional District Sports Association (FCDSA) Meet, a sports and cultural competition participated by various public and private elementary and secondary schools in the district;

WHEREAS, the Municipality of Tigbauan has appropriated the amount of One Hundred Seventy Thousand Pesos (P170,000.00) as Financial Assistance/Contribution to host municipality from 2018 SEF as identified in the Annual Budget of the Local School Board for FY 2018 of the Municipality of Tigbauan;

WHEREAS, the Municipality of Igaras requested for the release of the above-mentioned amount for the municipal contribution to the host municipality to be used for the first Congressional District Sports Association (FCDSA) Meet 2018;

WHEREAS, the amount of One Hundred Seventy Thousand Pesos (P170,000.00) shall be transferred to the Municipality of Igaras for FCDSA expenditures;

WHEREAS, premises considered, the Municipality of Tigbauan and the Municipality of Igaras hereby agree to the following:

1. *The Municipality of Tigbauan will monitor and evaluate the implementation of fund transferred;*
2. *The Municipality of Igaras shall take full responsibility in the proper disposition/disbursement of funds in the implementation in accordance with the implementing Guidelines and COA rules and regulations;*
3. *The Municipality of Igaras shall use the funds of the Tigbauan Municipal Government solely for the implementation of the specific activity/event;*
4. *The Municipality of Igaras, after each assistance, the Accountable Officer shall prepare and submit to the Tigbauan Municipal Government the Statement of Expenditures duly signed by the Municipal Mayor/FCDSA Meet Coordinator and verified by the COA.*

NOW THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Education and Civil Service* and duly seconded by Hon. Dennis T. Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Ricky Nulada, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada for and in behalf of the Municipality of Tigbauan to enter into a Memorandum of Agreement (MOA) with the Municipality of Igaras for the transfer of funds worth One Hundred Seventy Thousand Pesos (P170,000.000) as contribution for the First Congressional District Sports Association (FCDSA) Meet 2018.

RESOLVED FURTHER, to forward copies of this Resolution to the Hon. Mayor, Atty. Suzette Tenefrancia-Alquisada, to the Municipal Government of Igaras and to all concerned for their information and/or appropriate action.
