RESOLUTION AUTHORIZING THE BIDS AND AWARDS COMMITTEE (BAC) AND THE HEAD OF THE PROCURING ENTITY (HOPE) TO PROCEED WITH THE PROCUREMENT PROCESS FOR THE IMPLEMENTATION OF PERTINENT PROJECTS OF THE MUNICIPALITY OF TIGBAUAN AND TO SIGN ON AWARDS, CONTRACTS, AND ALL RELATED DOCUMENTS THERETO.

WHEREAS, the Local Chief Executive in a letter dated September 26, 2018 requested this Sangguniang Bayan for the passage of a *“Resolution Authorizing the Bids and Awards Committee and the Head of the Procuring Entity to Proceed with the Procurement Process for the Implementation of the Pertinent Projects of the Municipality of Tigbauan and to Sign on Awards, Contracts, and All Related Documents Thereto”*.
