RESOLUTION ATTESTING THAT THE TRUE LAST NAME OF ATHLETE, LORD CEDRIC, OF TIGBAUAN NATIONAL HIGH SCHOOL, TIGBAUAN, ILOILO, IS "TOLENTINO" AS SHOWN IN HIS SCHOOL AND OTHER PERTINENT RECORDS

WHEREAS, Lord Cedric Romero Tolentino is an athlete from Tigbauan National High School to play the sport SepakTakraw as part of the Tigbauan Delegation to the First Congressional District Sports Association Meet on November 6-10, 2018 in Igaras, Iloilo;

WHEREAS, in the Certificate of Live Birth issued by the Philippine Statistics Authority his name is LORD CEDRIC with middle name ROMERO, nothing was written in the space provided for his last Name;

WHEREAS, at the time of his birth, his parents Fernando V. Tolentino and Rhenee Rose Concepcion Romero were not yet legally married, however, his father signed an Affidavit of Acknowledgement/Admission of Paternity attached to his Certificate of Live Birth;

WHEREAS, the inadvertence or negligence of the Local Civil Registrar shall not prejudice concerned individual, thus Dep Ed Memorandum No. 156 s. 2016 provides that "In case there is a discrepancy in the entry of name between the Birth Certificate and Form 137, the entry in the Birth certificate shall prevail;

WHEREAS, same DepEd Order also provides for a remedy in case of discrepancy that a resolution issued by the Head of the Delegation attesting the true Last Name of the athlete as shown in the records must be submitted;
