RESOLUTION AUTHORIZING ROLAND T GENINE, PRINCIPAL II, TIGBAUAN CENTRAL ELEMENTARY SCHOOL, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO PROCESS DOCUMENTS AND CLAIM PAYMENT FOR JUST COMPENSATION OF AFFECTED STRUCTURES OF THE AFOREMENTIONED SCHOOL, IN RELATION TO THE IMPLEMENTATION OF THE ROAD-WIDENING PROJECT OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS.

WHEREAS, Iloilo-Antique Road is a national arterial road which serves as the main thoroughfare from the provinces of Iloilo to the province of Antique, vice versa, and serves as route from Iloilo to Boracay Island, via Antique;

WHEREAS, once these road and bridge widening/improvement projects are completed, transportation will be faster and more convenient;

WHEREAS, the continuous widening of roads and bridges along Iloilo-Antique Road is the top priority infrastructure project of the Department of Public Works and Highways, Iloilo First District Engineering Office and the Tigbauan Central Elementary School and is among those which will be affected by this road-widening project;

WHEREAS, the school fence when removed will affect the safety and protection of the learners;

WHEREAS, there is a need to recover payments from DPWH to reconstruct a replacement fence for the school;
