RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. SUZETTE TENEFRENCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHINMA UNIVERSITY OF ILOILO (PHINMA UI), ILOILO CITY FOR THE ON-THE-JOB TRAINING (OJT) PROGRAM FOR ITS STUDENTS

WHEREAS, PHINMA University of Iloilo (PHINMA UI), is a non-stock, academic organization, with official address at Rizal St., Iloilo City, herein represented its Chief Operating Officer, Eduardo Y. Arevalo;

WHEREAS, the Municipality of Tigbauan is a Local Government Unit, existing under the law of the Philippines with principal address at Tigbauan, Iloilo represented by its Municipal Mayor, Atty. Suzette T. Alquisada;

WHEREAS, during the internship program, the students will be required to undergo a hands-on training in the LGU on a part-time basis, for a period of not less than three hundred and sixty (360) hours for the first batch and another three hundred and sixty (360) hours for the second batch;

WHEREAS, the objective of the Internship Program is to enhance the employability and global competitiveness of the students, provide a beneficial network between the school and LGU and to institute curricular innovations responsive to the demands of the LGU, as well as the learning experience and training requirements of students;

WHEREAS, the Local Government Unit is considering and offering to the Schools, its OJT Program as a partner to achieve the strategic objectives of the Program. Pursuant thereof, qualified students of the School shall undergo on-the-job internship training by the LGU-Tigbauan;

WHEREAS, the Local Government Unit of Tigbauan shall only allow the Student Interns to work for not more than eight (8) hours per day excluding their one (1) hour lunch break and not more than six (6) days a week, from Monday to Saturday. An 8-hour shift shall be from 8am to 5pm or 9am to 6pm only;
