RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO MEMORANDUM OF AGREEMENTS (MOA) WITH LANDBANK OF THE PHILIPPINES (LBP) FOR THE FOLLOWING SERVICE FACILITIES: (A) LANDBANK'S VISA DEBIT CARD PAYROLL SYSTEM; (B) OFFSITE ATM INSTALLATION; (C) LANDBANK LINK.BIZ PORTAL AND (D) MOBILE-BASED SAVINGS-LINKED SALARY LOAN FACILITY.

WHEREAS, during the pre-session of the Sangguniang Bayan last November 21, 2018, the Landbank's deposit products and cash management solution with LGU Tigbauan were exhaustively discussed by the Land Bank of the Philippines representatives (*Plaza Libertad Branch, Iloilo City*), namely: Ms. Rocel P. Gargarita, *Department Manager*, Ms. Angela Albacete, *Marketing Officer* and Mariel E. Table, *Marketing Specialist*;

WHEREAS, the MUNICIPALITY OF TIGBAUAN, pursuant to the provisions of Republic Act No. 8792, otherwise known as the " *ELECTRONIC COMMERCE ACT OF 2000*," is currently undertaking the modernization of its facility to provide fast and efficient alternative payment collection services to its clientele;

WHEREAS, the MUNICIPALITY OF TIGBAUAN desires to avail of the following service facilities from Land Bank of the Philippines (LBP):

- Visa Debit Card Payroll System;
- installation of an Automated Teller Machine (ATM);
- operation of the LANDBANK Link.Biz Portal (*to allow partner-merchants' clients to directly transact with the LANDBANK payment gateway*)
- mobile-based savings-linked Salary Loan Facility (*to encourage savings and provide a loan window to qualified employees*)

WHEREAS, Memorandum of Agreements for the aforementioned service facilities will be entered into by the Municipal Mayor, Vice Mayor and the Land Bank representatives upon authorization of the Sanggunian;

WHEREAS, the four Memorandum of Agreements shall form part and shall be attached as **ANNEXES "A", "B", "C" and "D"** of this resolution;

Nulada and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan, to enter into Memorandum of Agreements (MOA) with Land Bank of the Philippines (LBP) for the following service facilities: (A) *Land Bank's Visa Debit Card Payroll System*; (B) *Offsite ATM Installation*; (C) *Land Bank Link.Biz Portal* and (D) *Mobile-Based Savings-Linked Salary Loan Facility*;
