RESOLUTION CONFORMING AND APPROVING THE CY 2019 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS, 10% SK FUND, 5% BDRRMF PLANS AND GAD ATTRIBUTIONS OF **BARANGAYS BAGACAY, BAGUMBAYAN AND LUBOG**, THIS MUNICIPALITY.

WHEREAS, the OIC-Municipal Budget Officer on November 27, 2018, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2019 Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the following barangays:

Barangay Bagacay CY 2019 General Annual Budget Involving an Appropriation of **P2,284,862.00**, 20% Development Fund in the amount of **P447,172.40**, 10% SK Fund in the amount of **P228,486.20**, 5% BDRRMF in the amount of **P114,243.10** and GAD Attribution in the amount of **P132,158.62** Approved by Sangguniang Barangay on October 16, 2018 and Enacted Under Appropriation Ordinance No. 2018-02;

Barangay Bagumbayan CY 2019 General Annual Budget Involving an Appropriation of **P2,449,428.00**, 20% Development Fund in the amount of **P478,885.60**, 10% SK Fund in the amount of **P244,942.80**, 5% BDRRMF in the amount of **P122,471.40** and GAD Attribution in the amount of **P359,288.56** Approved by Sangguniang Barangay on October 8, 2018 and Enacted Under Appropriation Ordinance No. 2018-02;

Barangay Lubog CY 2019 General Annual Budget Involving an Appropriation of **P1,529,337.00**, 20% Development Fund in the amount of **P300,367.40**, 10% SK Fund in the amount of **P152,933.70**, 5% BDRRMF in the amount of **P76,466.85** and GAD Attribution in the amount of **P182,168.37** Approved by Sangguniang Barangay on October 14, 2018 and Enacted Under Appropriation Ordinance No. 2018-01;

WHEREAS, the OIC-Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
