RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO SIGN CONTRACTS AND OTHER DOCUMENTS FOR THE PURCHASE OF LOT NO. 6384-A LOCATED AT BRGY. LINOBAYAN, TIGBAUAN, ILOILO FOR THE PROPOSED ECO-PARK AND MUNICIPAL CEMETERY PROJECTS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the present lot is being used as a dumping site of garbage of the Municipality of Tigbauan;

WHEREAS, it is prescribed under existing laws of DENR to rehabilitate the site so as to develop it for the preservation of the environmental surroundings;

WHEREAS, RA 9003 otherwise known as "The Ecological Solid Waste Management Act of 2000", specifically Section 37, states that: *"No open dumps shall be established and operated, nor any practice or disposal of solid waste by any person, including LGUs, which constitutes the use of open dumps for solid waste be allowed after the effectivity of the Act: Provided, that within three (3) years after the effectivity of this Act, every LGU shall convert its open dumps into controlled dumps, in accordance with the guidelines set in Section 41 of this Act. Provided, further, that no controlled dumps shall be allowed five (5) years following effectivity of this Act."* Therefore, all open dumps and controlled dump facilities should have been closed and phased out as of February 16, 2006."

WHEREAS, the site is conducive for conversion as eco-park and for the proposed municipal cemetery of the Municipality of Tigbauan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in Behalf of the Municipality of Tigbauan, to Sign Contracts and Other Documents for the Purchase of Lot No. 6384-A Located at Brgy. Linobayan, Tigbauan, Iloilo for the Proposed Eco-Park and Municipal Cemetery Projects in the Municipality of Tigbauan, Province of Iloilo;
