**Resolution No. 2019-001**

RESOLUTION AMENDING CERTAIN PROVISIONS OF RESOLUTION NO. 2018-120 ON THE FINAL AREAS TO BE PURCHASED BY THE MUNICIPALITY OF TIGBAUAN FOR THE ROAD RIGHT OF WAY INORDER THAT THE TOURISM ROAD BE REALIZED AND RATIFYING THE DEED OF SALE ENTERED INTO BY THE LOCAL CHIEF EXECUTIVE WITH THE PARTIES INVOLVED LAST DECEMBER 28, 2018.

WHEREAS, last September 26, 2018, this August Body passed Resolution No. 2018-120, authorizing the Local Chief Executive to sign on all Contracts, Agreements, and other Documents with the owners of the affected Lots identified necessary for the acquisition of the road right of way of the Municipality of Tigbauan in order that the Tourism Road connecting Iloilo-Antique Highway and Tan Pael Road in the Municipality of Tigbauan be realized;

WHEREAS, the final Sketch Plan integrating all issues and concerns, as corrected in the area to be purchased by the Municipality of Tigbauan, shall be the following:

*Lot 927-A-9-C=376.34 sq. m. owned by Maria Eleanor Tayo-Antiquiera, final area to be purchased is **404 sq. meters**;*

*Lot 927-A-9-C=71.78 sq. m. owned by Serlinda Pineda Schaffter, for donation;*

*Lot 1255-D-6-A=221.10 sq. m. owned by Limuel Tendero, final area to be purchased is **222 sq. meters**;*

*Lot 1255-D-5-A= 70.94 sq. m. owned by Patrick Gregory Tendero represented by Winifred Tendero, final area is **65 sq. meters**;*

*Lot 1255-D-9=1,340.21 sq. m. owned by the heirs of Andres P. Tendero represented by Francisca C. Tendero/Vic Tendero, final area is the following:*

*Lot 1255-D-9-G-2 - 62 sq. meters*

*Lot 1255-G-A-2 - 155 sq. meters*

*Lot 1255-D-9-G-3 - 274 sq. meters*

*Total Lot area to be purchased is= **491 square meters***
