Resolution No. 2019 – 004

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF SERVICE FOR THE ENGAGEMENT OF THE SERVICES OF MR. ORVILLO T. TANGENTE STARTING JANUARY 16, 2019 UNTIL JUNE 30, 2019.

WHEREAS, Mr. Orvillo T. Tangente was appointed on July 1, 2013 as *Security Officer II* and performs additional duties and responsibilities as *designated Municipal Administrator* of the Local Government Unit (LGU) of Tigbauan by virtue of Office Order No. 008 series of 2013;

WHEREAS, Mr. Orvillo T. Tangente tendered his retirement from office effective August 31, 2018;

WHEREAS, the LGU - Tigbauan is still in need of the extended services of Mr. Orvillo T. Tangente in order that the services of the Office of the Local Chief Executive will not be hampered. As Security Officer II, he shall be responsible for the keeping of confidential matters and important documents, which shall be arranged properly and settled;

WHEREAS, as Municipal Administrator *designate*, his extended services is also urgently needed because he has the knowledge of the transactions of the department during prior years;

WHEREAS, Mr. Orvillo Tangente has signified his intention and willingness to extend his services, to which the LGU has accepted;

WHEREAS, the contract of services of Mr. Orvillo Tangente is hereby engaged for the period, from January 16, 2019 until June 30, 2019, in consideration of the daily rate of P1,000.00 to be paid on a daily basis;

WHEREAS, it is understood that this contract does not create an employer and employee relationship between the LGU and Mr. Tangente, and the services rendered as stated

in the contract are not considered as bases for entitlements to leave privileges and other benefits enjoyed by the regular personnel of the LGU, such as but not limited to PERA, ACA and RATA;

WHEREAS, notwithstanding the fixed duration of the contract, the services of Mr. Tangente may be terminated earlier than the expiration date due to unsatisfactory service, unavailability of funds, early completion or discontinuance of the project, or other reasons within the control of Mr. Orvillo Tangente;

NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Education and Civil Service* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma, Hon. Ricky T. Nulada, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into a Contract of Service for the Engagement of the Services of Mr. Orvillo Tangente starting January 16, 2019 until June 30, 2019.

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, to Mr. Orvillo Tangente and all concerned for their information and/or appropriate action.
