RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF SERVICE FOR THE ENGAGEMENT OF THE SERVICES OF MRS. SALVACION TRAYFALGAR AS FINANCIAL ANALYST CONSULTANT STARTING JANUARY 16, 2019 UNTIL MARCH 31, 2019.”

WHEREAS, the Local Government Unit (LGU) of Tigbauan is in need of the services of Mrs. Salvacion Trayfalgar who shall be responsible for the settlement of the notice of disallowances issued by the Commission on Audit and to liquidate trust funds received by the Municipality of Tigbauan during prior years;

WHEREAS, her service is urgently needed as she has the knowledge of the transactions during prior years as former OIC Municipal Accountant;

WHEREAS, Mrs. Salvacion Trayfalgar has signified her intention, to which the LGU has accepted, to provide the service needed by the latter;

WHEREAS, Mrs. Salvacion Trayfalgar possesses the education, experience and skills required to perform the job as described in the contract and she attests that she is not related within the third degree of consanguinity or affinity to the hiring authority and/or representative of the LGU, and also has not been previously dismissed from government service by reason of an administrative offense;

WHEREAS, the contract of services of Mrs. Salvacion Trayfalgar is hereby engaged for the period, from January 16, 2019 until March 31, 2019 in consideration of the daily rate of P1,000.00 to be paid on a daily basis;

WHEREAS, it is understood that this contract does not create an employer and employee relationship between the LGU and Mrs. Trayfalgar, and the services rendered as stated in the contract are not considered as bases for entitlements to leave privileges and other benefits enjoyed by the regular personnel of the LGU, such as but not limited to PERA, ACA and RATA;

WHEREAS, notwithstanding the fixed duration of the contract, the services of Mrs. Salvacion Trayfalgar may be terminated earlier than the expiration date due to unsatisfactory service, unavailability of funds, early completion or discontinuance of the project, or other reasons within the control of Mrs. Salvacion Trayfalgar;

NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Education and Civil Service* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma, Hon. Ricky T. Nulada, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into a Contract of Service for the Engagement of the services of Mrs. Salvacion Trayfalgar as Financial Analyst Consultant starting January 16, 2019 until March 31, 2019.
