RESOLUTION AMENDING RESOLUTION NO. 2018-126 BY RE-ORGANIZING THE COMPOSITION OF THE DIFFERENT S.B. STANDING COMMITTEES

WHEREAS, consistent to the declared policy of Republic Act 7160 otherwise known as the Local Government Code of 1991, *the Sangguniang Bayan (S.B.) is a structure of Local Government that should be “.....more responsive and accountable” to the people whom we serve;*

WHEREAS, last October 10, 2018, Hon. Ricky T. Nulada was appointed and assumed office as S.B. Member to fill up the vacancy that resulted when Hon. Jerry Tuares filed his certificate of candidacy as Punong Barangay of Cordova Sur, this municipality;

WHEREAS, there is a dire need to re-organize the different S.B. Standing Committees, in order to assign committee chairmanship and membership to Hon. Ricky T. Nulada;

WHEREAS, by re-organizing the composition of these Standing Committees, all committees shall be rightfully assigned to members of the Sangguniang Bayan;

WHEREAS, the power to pass local legislation also carries with it the power to monitor their faithful compliance and meaningful execution;

WHEREAS, after an exhaustive discussion during the pre-session conference, the August Body has decided to give the Committee on Infrastructure & General Services chairmanship to Hon. Ricky Nulada as well as to assign him also as one of the members of the Committee on Transportation (*vice Hon. Dyossa Marie Teruñez*) so that Hon. **Teruñez** shall give full attention and dedication to her assigned committees; while other standing committees shall remain unaffected of this reorganization;
