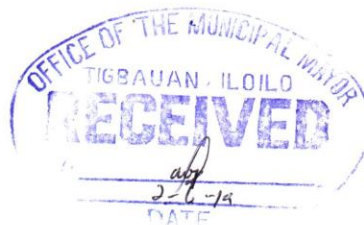

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH COLEGIO DEL SAGRADO CORAZON DE JESUS FOR THE MINIMUM OF 500 HOURS FIELD SOCIAL WORK EXPERIENCE OF STUDENTS

WHEREAS, Colegio Del Sagrado Corazon De Jesus, is a non-stock, academic organization, with official address at General Hughes Street, City Proper, Iloilo City, as represented by its President, Sr. Ma. Asuncion G. Evidente, DC;

WHEREAS, the Municipality of Tigbauan, is a Local Government Unit, existing under the law of the Philippines with principal address at Tigbauan, Iloilo, as represented by its Municipal Mayor, Atty. Suzette T. Alquisada;

WHEREAS, in the internship program the students will be required to undergo a hands-on field exposure training in the LGU Tigbauan for a minimum of Five Hundred (500) hours;
