**Resolution No. 2019-021**

RESOLUTION RECOGNIZING ROSALIA GENCIANA-GATON AS A CENTENARIAN OF THE  
MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Article XV, Section 4 of the Constitution declares that it is the duty of the family to take care of its elderly members while the State may design programs of social security for them;

WHEREAS, Republic Act (RA) No. 10868 or the Centenarians Act of 2016, grants P100,000.00 cash gift and other benefits and privileges to Filipino Centenarians from the President of the Philippines, whether they are residing in the Philippines or abroad;

WHEREAS, the Provincial Ordinance No. 2016-135 further grants an additional P30,000.00 cash gift to all Filipino Centenarians who reside in the Province of Iloilo;

WHEREAS, it is within the conferred powers of the Sangguniang Bayan as provided for in Section 17 (*Basic Services and Facilities*) of RA 7160 to exercise such other powers and discharge such other functions and responsibilities which are necessary, appropriate or incidental for the effective and efficient provision of basic services and facilities as enumerated therein particularly the establishment of the above program which greatly help to ensure the attainment of integrated services to the elderly;

WHEREAS, on December 13, 2017, this August Body passed Municipal Ordinance No. 2017-09, "AN ORDINANCE ESTABLISHING THE CENTENARIAN AWARD TO QUALIFIED CITIZENS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING FUNDS THEREFOR";

WHEREAS, the purposes of this Ordinance are to give full support and assistance to the well-being of the elderly and distinct recognition of the Centenarians, to encourage their families and the local government to set forth the valued Filipino

tradition of caring for the Centenarians and to express gratitude and appreciation to the elderly residents for their exemplary life;

WHEREAS, this ordinance particularly recognizes the rights of the elderly and their continued involvement as integral members of society and to grant benefits and privileges to all Filipino Residents of the Municipality of Tigbauan, Province of Iloilo who reach the age of one hundred (100) years;

WHEREAS, ROSALIA GENCIANA-GATON, born on February 15, 1919, is a resident of Barangay Buyuan, this municipality and will be celebrating her 100<sup>th</sup> birthday on February 15, 2019;

WHEREAS, ROSALIA GENCIANA-GATON, had rendered commendable service to the people of Brgy. Buyuan for four years as Punong Barangay from 1966 to 1970;

WHEREAS, ROSALIA GENCIANA-GATON, is married to the late Ceriaco Gatón and they are blessed with three children, namely: Jose Edgar, (*former S.B. member of this municipality*), Fermin and Roci Luz;
