**Barangay Guisian** CY 2019 General Annual Budget Involving an Appropriation of **P1,372,789.60**, 20% Development Fund in the amount of **P271,957.80**, 10% SK Fund in the amount of **P137,278.96**, 5% BDRRMF in the amount of **P68,639.48** and GAD Attribution in the amount of **P172,616.27** Approved by Sangguniang Barangay on December 2, 2018 and Enacted Under Appropriation Ordinance No. 2018-02;
