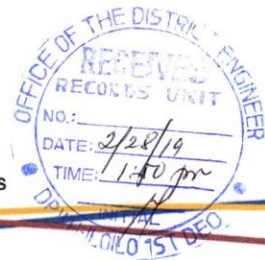

RESOLUTION INTERPOSING NO OBJECTION TO THE CUTTING OF TREES ALONG THE ILOILO-ANTIQUE ROAD, LOCATED AT BRGY. 1 (POBLACION), TIGBAUAN, ILOILO, TO GIVE WAY FOR THE WIDENING OF SIBALOM BRIDGE PROJECT OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH).

WHEREAS, the Department of Public Works and Highways (DPWH) will be implementing the proposed CY 2019 project, the Widening of Sibalom Bridge (B00327PN) along Iloilo-Antique Road, located at Brgy. Poblacion 1, Tigbauan, Iloilo;

WHEREAS, trees of various species within the road right-of-way limits will be affected by the said project and need to be cut, to give way to the widening activities especially along Brgy. 1 (Poblacion), Tigbauan, Iloilo;

WHEREAS, the DPWH is currently processing its application for the issuance of permit for the cutting of trees in the implementation of the said project;

WHEREAS, the Sangguniang Bayan Resolution interposing no objection on the cutting/removal of trees within the road right of way limits is one of the requirements for said application;
