RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA AND OIC-MUNICIPAL TREASURER, MS. ELMA G. TIONSAY, IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO OPEN BANK ACCOUNT WITH LANDBANK-LIBERTAD BRANCH, ILOILO CITY AND TO DESIGNATE THE SAME AS AUTHORIZED SIGNATORIES FOR VARIOUS BANK TRANSACTIONS.

WHEREAS, on November 28, 2018, the Sangguniang Bayan passed Resolution No. 2018-147, "Resolution Authorizing The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, For And In Behalf Of The Municipality Of Tigbauan, To Enter Into Memorandum Of Agreements (MOA) With Landbank Of The Philippines (LBP) For The Following Service Facilities: (A) Landbank's Visa Debit Card Payroll System; (B) Offsite ATM Installation; (C) Landbank Link.Biz Portal And (D) Mobile-Based Savings-Linked Salary Loan Facility";

WHEREAS, these service facilities were offered to the Municipality of Tigbauan by Landbank-Libertad Branch, Iloilo City;

WHEREAS, in order for the Landbank -Libertad Branch to begin the operation of these service facilities, one of the requirements is for the Municipality to open an account to the said bank;

WHEREAS, as part of the usual bank and government protocol, it is very necessary to have official signatories in order not to hamper the disbursement and withdrawal of funds from the official depository banks of the Municipality of Tigbauan;

WHEREAS, to ensure efficient and effective public service and in order that the transactions of the local government unit will not be hampered, it is imperative that this August Body shall therefore pass this needed resolution;
