WHEREAS, the OIC-Municipal Budget Officer on February 13, 2019, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2019 Annual Budget, 20% Development Plan, 10% SK Fund, 5% BDRRMF Plan and GAD Attribution of the following barangay:

Barangay Baguingin CY 2019 General Annual Budget Involving an Appropriation of **P3,496,010.00**, 20% Development Fund in the amount of **P685,282.00**, 10% SK Fund in the amount of **P349,601.00**, 5% BDRRMF in the amount of **P174,800.50** and GAD Attribution in the amount of **P685,282.00** Approved by Sangguniang Barangay on November 17, 2018 and Enacted Under Appropriation Ordinance No. 2018-01;
