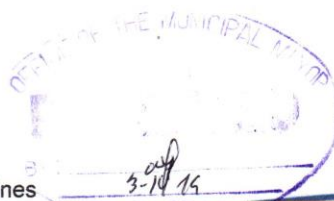

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF SERVICES FOR THE ENGAGEMENT OF THE SERVICES OF VARIOUS CHOREOGRAPHERS AND MUSICIANS FOR FIVE (5) COMPETING TRIBES IN THE 5TH PAGDAUG-SALUDAN FESTIVAL TRIBAL DANCE-DRAMA COMPETITION STARTING MARCH 1, 2019 UNTIL MARCH 15, 2019

WHEREAS, the Local Government Unit of Tigbauan is in need of the services of various choreographers and musicians for the five Competing Tribes to ensure best performance during the Tribal Dance-Drama Competition in the celebration of the 5th Pagdaug-Saludan Festival in the Municipality of Tigbauan;

WHEREAS, various choreographers and musicians have already signified their intentions to provide the needed services for said tribal competition;

WHEREAS, these choreographers and musicians possess the training, skills and expertise required to perform the job as described in the contract of services;

WHEREAS, the duration of the contract shall be fifteen (15) days from March 1, 2019 to March 15, 2019, at P1,000.00/day with the total amount of P15,000.00 per tribe which shall be paid after the end of the contracted date;

WHEREAS, it is understood that this contract does not create an employer and employee relationship between the LGU and the various choreographers and musicians of five Competing Tribes; that the services rendered shall not be considered as bases for entitlements to leave privileges and other benefits enjoyed by the regular personnel of the LGU, such as but not limited to PERA, ACA and RATA;

WHEREAS, notwithstanding the fixed duration of this contract, the services of various choreographers and musicians may be terminated earlier than the expiration date due to unsatisfactory service, unavailability of funds, early completion or discontinuance of the project, or other reasons within the control of the various choreographers and musicians;


