

*Barangay Dorong-an* CY 2019 General Annual Budget Involving an Appropriation of **P2,875,726.00**, 20% Development Fund in the amount of **P566,845.20**, 10% SK Fund in the amount of **P287,572.60**, 5% BDRRMF in the amount of **P143,786.30** and GAD Attribution in the amount of **P375,960.63** Approved by Sangguniang Barangay on October 15, 2018 and Enacted Under Appropriation Ordinance No. 2019-01;

*Barangay Sipitan* CY 2019 General Annual Budget Involving an Appropriation of **P1,487,409.00**, 20% Development Fund in the amount of **P295,081.80**, 10% SK Fund in the amount of **P148,740.90**, 5% BDRRMF in the amount of **P74,370.45** and GAD Attribution in the amount of **P177,672.46** Approved by Sangguniang Barangay on December 1, 2018 and Enacted Under Appropriation Ordinance No. 2018-02;
