RESOLUTION DECLARING AS **LEGAL AND VALID** BARANGAY BUYU-AN ORDINANCE NO.002-2018-"AN ORDINANCE PENALIZING CERTAIN INDIVIDUAL WHO ACCIDENTALLY AND INTENSIONALLY CAUSE DAMAGES TO BARANGAY INSTALLED PROJECT AND PROPERTIES AND OR ANY INSTALLATION OWNED BY THE LOCAL GOVERNMENT AND IMPLEMENTING PENALTIES FOR THE VIOLATION THEREOF" PROVIDED THAT **SECTION 4** THEREOF SHALL BE CORRECTED/AMENDED TO READ: "**ANY UNINTENTIONAL DESTRUCTION OR DAMAGES OF BARANGAY FACILITIES, BARANGAY EQUIPMENT, ELECTRICAL LINE, WATER PIPELINE, STREETLIGHT POST, ROAD SIGNBOARD STAND AND OTHERS THAT ARE CAUSED BY ANY TYPE OF VEHICLES, PRIVATE OR PUBLIC OR BY ANY INDIVIDUAL SHALL RENDER THE PERSON/S RESPONSIBLE LIABLE FOR THE DAMAGES CAUSED; PROVIDED THAT IF THE DESTRUCTION IS WILLFUL OR INTENTIONAL, THE PERSON/S RESPONSIBLE SHALL BE LIABLE TO PAY A FINE NOT EXCEEDING ONE THOUSAND PESOS (P1,000.00).**"

WHEREAS, the above-mentioned Barangay Ordinance was referred to this Committee for review and recommendation and after careful study, the committee has the following findings, to wit:

The ordinance was presented in a barangay assembly last October 14, 2018 and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

"SECTION 391. Powers, Duties and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;
- (14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;

(24)Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;

WHEREAS, the same is also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

NOW, THEREFORE, on motion of VICE MAYOR, ATTY. VIRGILIO T. TERUEL, *Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters* and duly seconded by Hon.Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, and Hon. Dyossa Marie Teruñez;

RESOLVED, to declare as **Legal and Valid** Barangay Buyu-an Ordinance No.002-2018-*"An Ordinance Penalizing Certain Individual Who Accidentally and Intensionally Cause Damages to Barangay Installed Project and Properties and or Any Installation Owned by the Local Government and Imposing Penalties for the Violation Thereof"* Provided that Section 4 Thereof shall be Corrected/Amended to Read: ***"Any Unintentional Destruction or Damages of Barangay Facilities, Barangay Equipment, Electrical Line, Water Pipeline, Streetlight Post, Road Signboard Stand and Others that are Caused by Any Type of Vehicles, Private or Public or by Any Individual shall Render the Person/s Responsible Liable for the Damages Caused; Provided that if the Destruction is Willful or Intentional, the Person/s Responsible shall be Liable to Pay a Fine Not Exceeding One Thousand Pesos (P1,000.00)."***
