RESOLUTION EXPRESSING DEEP GRATITUDE AND APPRECIATION TO ILOILO CITY ANTI-SMOKING TASK FORCE HEADED BY DIRECTOR IÑIGO GARINGALAO FOR HELPING THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, ILOILO TO EFFECTIVELY IMPLEMENT ITS ANTI-SMOKING ORDINANCE.

WHEREAS, the Sangguniang Bayan enacted last February 15, 2017 the Municipal Ordinance No. 2017-003 entitled, *"An Ordinance Prohibiting the Use, Sale, Distribution and Advertisement of Cigarettes and Other Tobacco Products in Certain Places, Imposing Penalties for Violations Thereof and Providing Funds Therefor and for Other Purposes;"*

WHEREAS, a Task Force has been created to aid in the implementation, enforcement and conduct educational awareness campaigns, information dissemination programs, and capacity building programs that will inform the constituents and train enforcement officers;

WHEREAS, to effectively implement this Ordinance, the ICAST Team headed by Director Iñigo Garingalao upon invitation of LGU Tigbauan conducted a three-day training among the members of the Smoke-Free Task Force on October 24-26, 2017 for 3 Cluster Barangays of the municipality composed of 52 Punong Barangays and 52 Barangay Tanods together with the LGU Officials and PNP Personnel;

WHEREAS, the ICAST Team headed by Director Iñigo Garingalao also conducted a Two-day orientation on December 3 and 4, 2018 for 52 Barangay Chairmen, Kagawad on Health and Brgy. Tanods for the first day and Owners of Business Establishments and Officials of Drivers Associations for the second day;

WHEREAS, due to the exemplary contributions and dedicated service of the ICAST Team headed by Dir. Iñigo Garingalao, the Smoke Free Task Force of Tigbauan was guided properly on how to formulate programs and significant activities in support of the effective implementation of the Ordinance;
