RESOLUTION ADOPTING THE ANNUAL BUDGET OF THE LOCAL SCHOOL BOARD (LSB) OF THE MUNICIPALITY OF TIGBAUAN FOR CALENDAR YEAR 2019 IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED THOUSAND PESOS (P3,700,000.00);

WHEREAS, R.A. 7160 otherwise known as Local Government Code of 1991, Section 99 (a) provides that the Local School Board shall determine, in accordance with the criteria set by the Department of Education, Culture and Sports, the annual supplementary budgetary needs for the operation and maintenance of public schools within the province, city, or municipality, as the case may be, and the supplementary local cost of meeting such as needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as this Code and other laws or ordinances may provide;

WHEREAS, the Local School Board approved its Budget for 2019 allocating this year's Special Education Fund (SEF) for the following purposes:
