RESOLUTION FOR THE REACTIVATION OF THE DORMANT SPECIAL TRUST FUND ACCOUNT (PCF) OF THE LGU UNDER LBP ACCOUNT NO. 0032-1511-59 AND DESIGNATING ATTY. SUZETTE TENEFRENCIA-ALQUISADA AND MS. ELMA G. TIONSAY, ACTING MUNICIPAL TREASURER - MUNICIPAL TREASURER'S OFFICE, AS AUTHORIZED SIGNATORIES THEREOF.

WHEREAS, on April 12, 2012 the Municipality of Tigbauan had been one of the recipient municipalities of the Seal of Good Housekeeping, an award given by the Department of the Interior and Local Government with a corresponding grant of One Million Pesos (P1,000,000.00) worth of project;

WHEREAS, for the release of such cash award and as required by the Department of the Interior and Local Government, the Municipality of Tigbauan had decided to open a Special Trust Fund Account (PCF) with Land Bank of the Philippines (LBP) under Account No. 0032-1511-59 on April 23, 2012;

WHEREAS, in February 2018, LBP Special Trust Fund Account No. 0032-1511-59 of the Municipality of Tigbauan was declared/reclassified by LBP to be in a dormant status by reason of inactive bank transactions;

WHEREAS, in a letter dated April 1, 2019, Atty. Suzette T. Alquisada, Municipal Mayor requested the Sangguniang Bayan for the urgent passing of a *Resolution for the reactivation of the dormant Special Trust Fund Account (PCF) of the LGU and Designating Atty. Suzette Tenefrancia-Alquisada and Ms. Elma G. Tionsay, OIC- Municipal Treasurer's Office as authorized signatories for LBP Account No. 0032-1511-59;*
