RESOLUTION APPROVING THE 2018-2021 LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) OF THE MUNICIPALITY OF TIGBAUAN, ILOILO.

WHEREAS, there is an urgent need for Local Government Units (LGU) to formulate a scientific and risk based plan that analyzes the impacts of climate change, giving priority to the most vulnerable communities as well as the areas and ecosystems within their territories. The formulation process should be consultative and participated by different sectors and also of the communities. This ensures community ownership of the plan and guarantees the cooperation on the implementation of the climate change related Projects, Programs and Activities;

WHEREAS, Section 14 of RA 9729 otherwise known as Climate Change Act of 2009 provides among others that the LGU shall be the frontline agencies in the formulation, planning and implementation of Climate Change Action Plans (CCAP) in their respective areas, consistent with the provisions of the Local Government Code, the Framework and the National Climate Change Action Plan;

WHEREAS, the Municipality of Tigbauan, just like any other municipalities is extremely vulnerable to the effects of climate change. Some areas were also identified as high risk from flooding and landslides due to heavy rains, and if left unattended, will surely cause harm and damage to lives and properties.

WHEREAS, in a letter dated April 30, 2019, the Hon. Mayor, Atty. Suzette T. Alquisada, requested this August Body for the urgent passage of a "Resolution Approving The 2018-2021 Local Climate Change Action Plan (LCCAP) Of The Municipality Of Tigbauan, Iloilo."

WHEREAS, the said 2018-2021 Local Climate Change Action Plan (LCCAP) of this municipality, was formulated to ensure and strengthen the adaptation and mitigation strategies aimed to address the challenges posed by climate change. The plan will serve as a roadmap that will guide the Municipal Government of Tigbauan in implementing its climate change and disaster risk sensitive development programs and projects;
