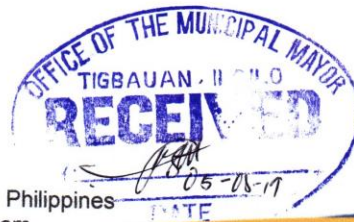

**Resolution No. 2019-041**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH PRIVATE INDIVIDUALS FOR PSYCHOSOCIAL SUPPORT AND MEDICAL ASSISTANCE DURING DISASTERS AND EMERGENCIES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

**WHEREAS**, Republic Act No. 10121 mandates the State to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated, and proactive in lessening the socioeconomic and environmental impacts of disasters including climate change, and promote involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community;

**WHEREAS**, one of the areas of concerns that must be addressed is rehabilitation in the aftermath of disaster wherein recovering from the impact of disasters is consistent with the provisions of R. A. 10121, particularly Section 2, paragraphs (k) and (l) thereof;

**WHEREAS**, one of the integral disaster mitigation measures necessary in addressing the vulnerabilities aimed at minimizing the impact of disasters is Psychosocial Support that helps individuals and communities to heal the Psychological wounds and rebuild social structures after an emergency or a critical event and that it can help change people into active survivors rather than passive victims;

**WHEREAS**, it is necessary that this municipality shall endeavor to forge a Memorandum of Understanding (MOU) with private physicians (namely: Dr. Elvie Dieron, Dr. Irene Escanlar, Dr. Suzette Marie H. Banno, Dr. Roel Jarina and Dr. Ariel Arguez) and as Tigbauanons to address the Psychological and Social problems and Medical Services of individuals during and after emergencies and disasters;

**WHEREAS**, the Municipality of Tigbauan, as the first party to the MOU shall provide medical drugs, and other medical needs during their services in times of disaster;

**WHEREAS**, the Private Physicians, as the second party to the MOU shall:

1. *Provide for the medical/dental needs of individual patients and affected family members in times of disaster.*
2. *Provide psychosocial support services that address the specific needs of vulnerable groups (e.g. women, children, etc.);*
3. *Provide counseling and support that will ensure sustainability, continuity of interventions and community development.*

NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Peace and Order and Public Safety* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Suzette Marie Hilado-Banno, Hon. Ariel Bernardo, Hon. Julius Ledesma, Hon. Ma. Gerrilyn Santuyo-Camposagrado, Hon. Ricky Nulada, Hon. Jerry Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into a Memorandum of Understanding (MOU) With Private Individuals for Psychosocial Support and Medical Assistance During Disasters and Emergencies in the Municipality of Tigbauan, Province of Iloilo;
