WHEREAS, Republic Act No. 1965 or the Comprehensive Dangerous Drugs Act of 2002 mandates that local government units should provide abuse treatment and rehabilitation services to drug dependents;

WHEREAS, the Municipal Anti- Drug Abuse Council (MADAC) proposed to conduct a Community - Based Drug Rehabilitation to Persons Who Used Drugs (PWUDs) in accordance with the adopted Peace and Order and Public Safety (POPS) Plan;




