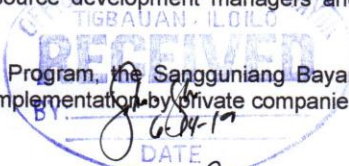
RESOLUTION IMPLORING COMPLIANCE AND IMPLEMENTATION BY PRIVATE COMPANIES OF THE DRUG-FREE WORKPLACE PROGRAM IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Section 47 of Republic Act No. 1965 or the Comprehensive Dangerous Drugs Act of 2002 mandates the implementation of the drug-free workplace program in private companies, to read:

"Section 47. Drug-Free Workplace. – It is deemed a policy of the State to promote drug-free workplaces using a tripartite approach. With the assistance of the Board, the Department of Labor and Employment (DOLE) shall develop, promote and implement a national drug abuse prevention program in the workplace to be adopted by private companies with ten (10) or more employees. Such program shall include the mandatory drafting and adoption of company policies against drug use in the workplace in close consultation and coordination with the DOLE, labor and employer organizations, human resource development managers and other such private sector organizations."

WHEREAS, such program "shall include the mandatory drafting and adoption of company policies against drug use in the workplace in close consultation and coordination with the DOLE, labor and employer organizations, human resource development managers and other such private sector organizations;"

WHEREAS, considering the noble intention of the Program, the Sangguniang Bayan deem it proper and appropriate to implore compliance and implementation by private companies of the Drug-Free Workplace Program in the Municipality;
