
RESOLUTION APPROVING THE CREATION OF THE INTERIM ANTI-DRUG ABUSE COUNCIL ADMINISTRATIVE BOARD OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Section 21 of Republic Act No. 1965 or the "Comprehensive Dangerous Drugs Act of 1992" provides for the creation of the Anti-Drug Abuse Council Administrative Board that will hear complaints regarding drug-related public nuisance through an ordinance;

WHEREAS, pending the creation of the permanent Administrative Board through an ordinance, the Municipal Council deem it necessary to create the same in an interim capacity which shall exercise the functions of the Board for the time being;

WHEREAS, the Interim ADAC Administrative Board shall be composed of the following:

BE IT RESOLVED, to approve the creation of the Interim Anti-Drug Abuse Council Administrative Board of the Municipality of Tigbauan.


