RESOLUTION ADOPTING SANGGUNIANG PANLALAWIGAN RESOLUTION NO. 2019-101-  
"RESOLUTION DECLARING THE ENTIRE PROVINCE OF ILOILO UNDER THE STATE OF CALAMITY  
BROUGHT ABOUT BY DROUGHT DUE TO EL NIÑO PHENOMENON, APPROVING THE MEASURES  
ON THE EFFECTS OF EL NIÑO PHENOMENON WITH A CORRESPONDING BUDGET IN THE TOTAL  
AMOUNT OF THIRTY ONE MILLION FOUR HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED  
FIFTY (P31,464,350.00) TO BE IMPLEMENTED BY THE CONCERNED LOCAL GOVERNMENT UNITS  
HAVING DECLARED THEIR AREAS UNDER THE STATE OF CALAMITY, APPROVING THAT THE  
CHARGES OF THE SAID MEASURES BE MADE AGAINST THE AVAILABLE PROVINCIAL DISASTER  
RISK REDUCTION AND MANAGEMENT FUND-TRUST FUND OF THE PROVINCE OF ILOILO, AND  
AUTHORIZING THE RELEASE AND DISBURSEMENT OF THESE FUNDS" OF THE PROVINCE OF  
ILOILO."

WHEREAS, in a letter dated June 10, 2019, the Hon. Mayor Atty. Suzette Tenefrancia-Alquisada requested this August Body for the urgent passage of a "Resolution Adopting Sangguniang Panlalawigan Resolution No. 2019-101 of the Province of Iloilo and Declaring the Municipality of Tigbauan Under the State of Calamity Brought About by Drought Due to El Niño Phenomenon;"

WHEREAS, in view thereof and considering further that the LGU-Tigbauan is one of the municipalities in the Province of Iloilo which is seriously affected brought about by the depressing effects of the long drought of the EL Niño Phenomenon, it is but proper and essential to adopt said provincial resolution;

RESOLVED, to adopt Sangguniang Panlalawigan Resolution No. 2019-101- "Resolution Declaring the Entire Province of Iloilo Under the State of Calamity Brought About by Drought due to El Niño Phenomenon, Approving the Measures on the Effects of El Niño Phenomenon With a Corresponding Budget in the Total Amount of Thirty One Million Four Hundred Sixty Four Thousand Three Hundred Fifty (P31,464,350.00) to be Implemented by the Concerned Local Government Units Having Declared their Areas Under the State of Calamity, Approving that the Charges of the Said Measures be Made Against the Available Provincial Disaster Risk Reduction and Management Fund-Trust Fund of the Province of Iloilo, and Authorizing the Release and Disbursement of these Funds" of the Province of Iloilo;
