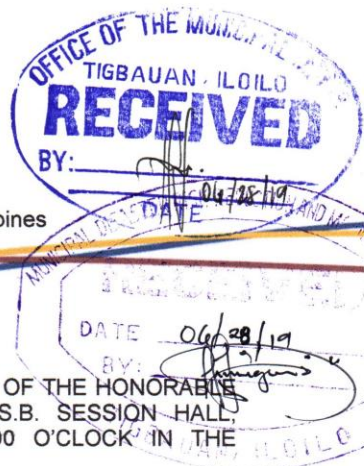

RESOLUTION ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 2019-01 AND DECLARING THE MUNICIPALITY OF TIGBAUAN UNDER THE STATE OF CALAMITY BROUGHT ABOUT BY DROUGHT DUE TO EL NIÑO SOUTHERN OSCILLATION (ENSO) PHENOMENON;

WHEREAS, the Sangguniang Panlalawigan of the Province of Iloilo has already declared the entire Province under the state of calamity as per Resolution No. 2019-101, entitled: "Resolution Declaring the Entire Province of Iloilo Under the State of Calamity Brought About by Drought Due to El Niño Phenomenon, Approving the Measures on the Effects of El Niño Phenomenon With a Corresponding Budget in the Total Amount of Thirty One Million Four Hundred Sixty Four Thousand Three Hundred Fifty (P31,464,350.00) to be Implemented by the Concerned Local Government Units Having Declared their Areas Under the State of Calamity, Approving that the Charges of the Said Measures be Made Against the Available Provincial Disaster Risk Reduction and Management Fund-Trust Fund of the Province of Iloilo, and Authorizing the Release and Disbursement of these Funds";

WHEREAS, in a letter dated June 10, 2019, the Hon. Mayor Atty. Suzette Tenefrancia-Alquisada requested this August Body for the urgent passage of a resolution adopting said Sangguniang Panlalawigan Resolution No. 2019-101;

WHEREAS, in another letter dated June 25, 2019, the Hon. Mayor Atty. Suzette Tenefrancia-Alquisada further requested this August Body for the urgent passage of a "Resolution Adopting the Municipal Disaster Risk Reduction and Management Council (MDRRMC) Resolution No. 2019-01 and Declaring the Municipality of Tigbauan Under the State of Calamity Brought About by Drought Due to El Niño Southern Oscillation (ENSO) Phenomenon;"

WHEREAS, as stated in said MDRRMC Resolution No. 2019-01, the Municipal Agriculture Office, conducted a survey of the affected crops and livestock to determine the extent of damage of ENSO in 52 barangays of this municipality, and based on the assessment and evaluation of said office, the total value of damaged crops and livestock amounted to P21,987, 217, affecting 27.9% out of the 62,706 total population of the Municipality of Tigbauan;

WHEREAS, in view thereof and considering further that Tigbauan is one of the municipalities in the Province of Iloilo which is seriously affected by the depressing effects of the long drought of the EL Niño Phenomenon, it is but essential and obligatory that this August Body should also declare a state of calamity in this Municipality;

NOW THEREFORE, on motion of HON. JERRY T. TUARES, *Chairman, Committee on Barangay Affairs* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Dyossa Marie Teruñez;

RESOLVED, to adopt MDRRMC Resolution No. 2019-01 and Declaring the Municipality of Tigbauan Under the State of Calamity Brought About by Drought Due to El Niño Southern Oscillation (ENSO) Phenomenon;"

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, and to all concerned for their information.
