

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH DEPED SCHOOLS DIVISION OF ILOILO FOR THE **CONVERSION OF LUBOG PRIMARY SCHOOL TO LUBOG ELEMENTARY SCHOOL**

WHEREAS, there is in need to convert Lubog Primary School into a complete Elementary School;

WHEREAS, the conversion of Lubog Primary School into a complete elementary school will give great benefit to the people of Lubog in particular and the DepEd District of Tigbauan in general;

WHEREAS, the Municipality of Tigbauan, Iloilo agrees to be a partner of DepEd in the implementation and promotion of its programs, projects and activities;

WHEREAS, for and in consideration of the terms and conditions hereinafter set forth, the parties hereby agree on the following provisions:

A. ROLES AND RESPONSIBILITIES OF DEPED:

1. The DepEd shall spearhead the implementation of the school's education curriculum;
2. The DepEd shall work for the school's funding and requirement for Personnel Services, Maintenance and other Operating Expenses and Capital Outlay in the General Appropriate Act, and the subsequent issuances Agency Code;
3. The DepEd shall ensure the designation of additional permanent teachers who possess the required qualifications;
4. The DepEd shall monitor the operation of Lubog Elementary School.

B. ROLES AND RESPONSIBILITIES OF THE MUNICIPALITY OF TIGBAUAN:

The Municipality of Tigbauan shall provide funds for the Lubog Elementary School, which, among others, are for the following:

- a. Construction of the additional Classrooms.

- b. *Procurement of Educational Facilities, Furniture and Instructional Materials.*
- c. *Provide salaries for the LGU Funded Teachers.*
- d. *Continue to provide financial assistance through the Special Educational Fund.*

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada , for and in behalf of the Municipality of Tigbauan to enter into Memorandum of Agreement (MOA) with DepEd Schools Division of Iloilo for the conversion of Lubog Primary School, to Lubog Elementary School,
