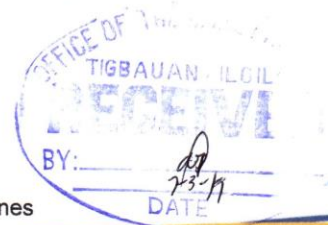

TIONSAY AS THE OFFICIAL SIGNATORIES IN ALL OFFICIAL TRANSACTIONS WITH THE LAND BANK OF THE PHILIPPINES (LBP), DEVELOPMENT BANK OF THE PHILIPPINES (DBP), AND PHILIPPINE VETERANS BANK (PVB), EFFECTIVE JUNE 30, 2019.
