

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH VARIOUS DEPED SECONDARY SCHOOLS IN THE MUNICIPALITY OF TIGBAUAN FOR THE TRANSFER OF FUNDS AS FINANCIAL ASSISTANCE FROM 2019 SPECIAL EDUCATION FUND (SEF)

WHEREAS, under the Local Government Code, the Local Government Units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible space to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, as convergence strategy, the Municipal Government of Tigbauan recognizes and appreciates the efforts and participation of the various Secondary Schools in responding to the needs of the schools and the students/learners;

WHEREAS, the Municipal Government of Tigbauan has appropriated funds for the different schools as Financial Assistance from 2019 SEF in the Annual Budget of the Local School Board;

WHEREAS, the Secondary Schools identify their priority projects for improvements and repair of school buildings and facilities;

WHEREAS, the amount of FIFTY THOUSAND PESOS (P50,000.00) each shall be transferred to the different Secondary Schools for implementation of priority projects;

WHEREAS, premises considered, the Municipality of Tigbauan and the Secondary Schools hereby agree to the following:

- 1. The Municipality of Tigbauan will monitor and evaluate the project;
- The Secondary School shall take full responsibility in the proper disposition/disbursement of funds in the implementation in accordance with the implementing Guidelines and COA rules and regulations;



- 3. The DepEd Secondary School shall use the funds of the Tigbauan Municipal Government solely for the implementation of the specific project; and the project shall be implemented within the period of four (4) months from date of receipt;
- The DepEd Secondary School, after each assistance, the Accountable Officer shall prepare and submit to the Tigbauan Municipal Government the Statement of Expenditures duly signed by the School Head and verified by COA.

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for in behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement (MOA) with various DepEd Secondary Schools in the Municipality of Tigbauan for the transfer of funds as Financial Assistance from 2019 Special Education Fund (SEF)
