RESOLUTION CALLING FOR THE HOLDING OF PUBLIC BIDDING ON THE GRANT OF FISHERY PRIVILEGES, CONCESSIONS, LEASE OR CONTRACTS TO INTERESTED AND QUALIFIED APPLICANTS FOR THE ESTABLISHMENT/INSTALLATION OF FISH CORRALS (PUNOT) OR STATIONARY FISH LIFT NET (TANGKAL-TANGKAL) AND STATIONARY FILTER NETS (SALUDAN) IN THE DIFFERENT FISHING ZONES OF TIGBAUAN, ILOILO ON **AUGUST 6, 2019, 1:30 P.M. AT THE MUNICIPAL, CONFERENCE ROOM**

**WHEREAS, Municipal Ordinance No. 2014-010**, otherwise known as "AN ORDINANCE ENACTING THE ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN", **Chapter 10, Article J- Section 1D No. 18** thereof provides:

*"18. Time and Place of Auction. The Sangguniang Bayan shall, in a resolution, provide for the holding of the public bidding for the granting of the concessions, lease or contracts, specifying the time, date and venue of such auction, the minimum bids, the amount to be deposited for entitlement to participate, the procedure to be followed by the committee, and the amount of bond as guaranty of good faith and for satisfactory compliance to the terms of the grant or license. Thus, the grant of lease of fishery rights through public auction shall be for a period of one year and in cash basis of 100%."*

**WHEREAS**, hereunder provided are the different fishing zones in the Municipality of Tigbauan, which are the subject of this public bidding with the required minimum amount *bid* (as provided under Chapter 10, Section 1D 21 of the said code);

**WHEREAS**, the following procedure shall be followed during the conduct of the public auction/bidding by the Bidding Committee:

- a.) The Pre-qualification Bids and Awards Committee on Fisheries comprising of the *Municipal Mayor as Chairman and with the following four (4) Members: 1.) Chairman, Committee on Agriculture, Aquatic Resources and Cooperatives; 2.) Vice Chairman, Committee on Agriculture, Aquatic Resources and Cooperatives; 3.) Municipal Treasurer and 4.) Municipal Agriculture Officer* - shall cause the publication of the notice to bid in the local media, if any, in the bulletin board of the Municipal hall and in two conspicuous places in the municipality for a period of **not less than 10 days prior to the holding of such auction**. The agenda and other relative information to the bidding shall be deliberated by the committee at least one week before such public auction;
- b.) Interested and qualified parties (*as provided under Chapter 10 - Article J Section 1.B.6 of the Environment Code of this Municipality*) may submit their proposed Bid in the sealed envelope to the Office of the Municipal Treasurer not later than the bidding time and date (**which is August 6, 2019, 1:30 o'clock in the afternoon**) together with the non-refundable Bid fee in the amount of Three Hundred Pesos (P300.00) only;
- c.) The sealed Bid envelope containing the Bid duly signed by the bidder or his authorized representative will be marked as "PROPOSAL FOR ERECTING ( FISH CORRAL or LIFT NET or STATIONARY FILTER NET ) AT THE DESIRED FISHING ZONE and such proposal shall be accompanied with a cash Bid value (100% of winning Bid);
- d.) Bidders or their representatives (*which shall be authorized in writing*) are requested to be present at the designated place during the scheduled bidding time and date specially when bids will be opened. Provided however, that person or persons with Standing Fishery Accounts with the Municipality of Tigbauan are disqualified to participate in the Bidding;
- e.) The grant of lease of fishery rights through this public auction shall be for a period of one year;

**WHEREAS**, the Pre-qualification Bids and Awards Committee on Fisheries reserves the right to reject any Bids, waive any formality in the Bidding and to accept only such Bids as maybe considered advantageous to the Municipality of Tigbauan;


