RESOLUTION REQUESTING ASSISTANCE FROM THE PROVINCIAL GOVERNMENT THROUGH HONORABLE ARTHUR D. DEFENSOR, JR., GOVERNOR, PROVINCE OF ILOILO FOR THE IMPROVEMENT OF ACCESS ROAD GOING TO BARANGAY DAPDAP PUBLIC CEMETERY, TIGBAUAN, ILOILO.

WHEREAS, Brgy. Dapdap and its neighboring barangays are among the far-flung barangays of the Municipality of Tigbauan;

WHEREAS, due to its distance, it had been deprived of the convenience being enjoyed by other constituents of the barangays near the Poblacion area, one of which is the public cemetery;

WHEREAS, a public cemetery is imperative and essential for the constituents of Brgy. Dapdap and its neighboring barangays;

WHEREAS, former Vice Mayor Agaton Tumabotabo has a piece of land situated in Brgy. Dapdap and was generous enough to donate a portion of it to the barangay purposely to be used as a public cemetery;

WHEREAS, considering that the donated lot is situated on a hilltop, the road going there is rough and not accessible by vehicles especially during rainy season;

WHEREAS, the said road necessitates improvement and development to make the cemetery accessible and convenient for the people;
