RESOLUTION ENDORSING THE DESIGNATION OF LIRA T. CAZEÑAS AS OFFICE OF THE SENIOR CITIZEN AFFAIRS (OSCA) HEAD OF THE MUNICIPALITY OF TIGBAUAN FOR A TERM OF THREE (3) YEARS STARTING JULY 01, 2019

WHEREAS, Mrs. Lira T. Cazeñas has been appointed as the new Chairman of the Office of Senior Citizens Affairs (OSCA), Tigbauan Chapter by Hon. Atty. Suzette Tenefrancia- Alquisada, Municipal Mayor;

WHEREAS, Mrs. Lira T. Cazeñas is 69 years old, a resident of Brgy. 9-Poblacion, Tigbauan and a graduate of Bachelor of Science in Education at Colegio del Sagrado Corazon de Jesus in 1970, had rendered public service by being a High School Teacher for 38 years, 15 years of these were rendered as High School Principal, the first two (2) years were at Nalundan National High School, Guimbal, Iloilo and the last Thirteen (13) Years were at Tigbauan National High School and from where she retired in 2010. With these credentials, she well-deserved to be the Chairman of the OSCA, Tigbauan Chapter;

WHEREAS, as OSCA Chairman, she will serve the interest of Senior Citizens and shall not be removed or replaced from office except for reasons of death, permanent disability or ineffective performance of her duties to the detriment of her fellow Senior Citizens;

WHEREAS, she will be receiving an honorarium of Five Thousand (P5,000.00) Pesos per month and shall be entitled to per diem for every official travel and/or attendance to seminar/training/workshop/convention relevant and beneficial to the Senior Citizens of this municipality;
