RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH REPRESENTATIVE PEDRO G. TRONO MEMORIAL HOSPITAL (RPGTMH) FOR THE REFERRAL FACILITY ON OUTSOURCED SERVICES

WHEREAS, *Article 25, "Responsibility for Delivery of Basic Services and Facilities: The LGU shall, in addition to their existing functions and responsibilities, provide basic services and facilities devolved to them covering, but not limited to the following: ...(c.) Subject to the provisions of Rule XXIII on local health boards, and in accordance with standards and criteria of the Department of Health (DOH), provision on health services";*

WHEREAS, one of the provisions of health services is access to secondary and tertiary health services;

WHEREAS, the Municipality of Tigbauan does not have a complete facility to provide Chest X-ray examination services to its patients and wishes its patients to be provided with the services by the Rep. Pedro G. Trono Memorial Hospital;

WHEREAS, the Municipality of Tigbauan caters basic health services to its constituents especially *PCB- entitled members and dependents*;

WHEREAS, there is a need to establish a partnership and referral system with other health service providers/facilities in order to improve the delivery of quality health care to patients;

WHEREAS, the Rep. Pedro G. Trono Memorial Hospital has a diagnostic facility capable of providing **Chest X-ray examination services** among others,
