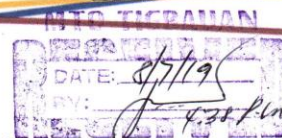

RESOLUTION CONFIRMING THE APPOINTMENT OF MS. ELMA G. TIONSAY AS MUNICIPAL TREASURER OF THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, Ms. Elma G. Tionsay has served the Municipality of Tigbauan for quite a number of years and has showed her dedication and commitment to service, and most of all, she was able to cleanse the local treasury of its long-time controversy;

WHEREAS, on September 16, 2015, Ms. Elma G. Tionsay, Local Treasury Operations Officer III, was designated as Acting Municipal Treasurer of LGU-Tigbauan, in view of the suspension order of Mr. Manuel T. Tabalada, Jr., the former Municipal Treasurer,;

WHEREAS, on February 9, 2018, the position of Municipal Treasurer was permanently vacated, due to the mandatory retirement of Mr. Manuel T. Tabalada, Jr. at age 65;

WHEREAS, it is just necessary and appropriate to fill up the position in the best interest of the service, due to the permanent vacancy created;

WHEREAS, during her "acting" capacity as Municipal Treasurer, she was able to achieve the following for the Municipality of Tigbauan:

- Contributed in the implementation of e-BPLS in 2017 thru e-GOV4MD
- Awarded as 9th place in the Real Property Tax Collection (Category A) in the entire Province of Iloilo for the FY 2017
- Contributed in the attainment of award as First Place in the Real Property Tax Collection (Category B) in the entire Province of Iloilo for FC 2014.

WHEREAS, because of her work experience as "OIC" to "acting" Municipal Treasurer and her exemplary performance in achieving the sound fiscal operation of the local treasury of the Municipality of Tigbauan (from September 16, 2015 – up to the present), Mayor Suzette Tenefrancia-Alquisada strongly recommended Ms. Elma G. Tionsay, to the Bureau of Local Government Finance, to be appointed as the Municipal Treasurer of LGU-Tigbauan;
