

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – ENVIRONMENTAL MANAGEMENT BUREAU (EMB), REGION VI AND BARROC ELEMENTARY SCHOOL FOR THE IMPLEMENTATION OF NATIONAL ECO-SAVERS PROGRAM (NEP) IN PUBLIC ELEMENTARY AND SECONDARY SCHOOLS IN THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, the Ecological Solid Waste Management Act of 2000 (RA 9003), provides the legal framework for promoting the systematic, comprehensive and ecological measures for avoiding the generation of solid waste, reducing waste and the final safe disposing of waste in order to protect public health and the environment;

WHEREAS, Section 8 of RA 9003, mandates the DENR to, among others, provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, the DENR fosters the strategy of partnerships among stakeholders such as government agencies, non-governmental organizations (NGOs), the youth in the private and public sector in the promotion of Ecological Solid Waste Management;

WHEREAS, Article I Section 2 (g) of RA 9003 states that Local Government Units (LGUs) have the primary enforcement and of solid waste management while establishing a cooperative effort among the national government, other local government units, non-government organizations and the private sector;

WHEREAS, RA 9003 mandates the LGUs to provide efficient, reliable, and universal collection services and environmentally safe disposal of waste;

WHEREAS, the existing public school system within the LGU is a valuable resource that can be tapped in the implementation of local ecological solid waste management program;

WHEREAS, for and in consideration of these premises and the mutual covenants as stated in MOA, the PARTIES do hereby agree as follows:

Section 1.Objectives

The Parties agree to collaborate in the establishment of a National Eco-savers Program (NEP) in public Elementary and High Schools in cooperation with concerned local City/Municipal governments with the following general objectives:

- Reduce the amount of solid waste generated by households through the collection of recyclable materials by elementary and high school students;
- Encourage students even at a young age to practice waste segregation at source and collection of recyclable materials;
- 3. Establish the NEP in Public Elementary and High Schools with the following components:
 - Collection of recyclable materials from students;
 - Segregation of collected recyclable materials;
 - Establishment of a School Materials Recovery Facility (MRF);
 - Establishment of an incentive system (waste exchange) for students who have collected the recyclable materials;
- 4. Establish a market for recyclables (or a recycle exchange system) by the concerned LGUs;
- Document experiences/lessons learned and recommendations for implementation of the program in other urban centers of the country.

Section 2.Role of the DENR through the Environmental Management Bureau (EMB):

- Provide technical and funding support of Twenty-Five Thousand Pesos (Php 25,000.00) to facilitate assistance to the (Barroc Elementary School) Public Elementary School;
 - a. In enabling the schools and the concerned LGUs to implement the NEP covered by this agreement;
 - b. In formulating and implementing the NEP, establishment of Materials Recovery Facility (MRF), linking with junkshops for the marketing of recyclable wastes and determination of waste diversion as a result of the systems introduced; and
- Provide the over-all coordination, monitoring among the Parties to this Agreement to ensure the attainment of the objectives of the Agreement;
- Submit Quarterly Accomplishment/Progress and Final Reports, as well as Financial/Liquidation Report of the NEP implementation;

Section 3.Role of the LGU:

- 1. Provide counterpart resources to assist/augment the implementation of this Agreement as follows:
 - Designate Project Officer to facilitate coordination and implementation of the project;
 - Financial or other forms of support for the project as covered by this Agreement, subject to availability of resources;
- To accredit or issue Mayor's Permit or with Barangay Clearance to a Junkshop or Consolidator actively operating in the area that shall undertake the following to wit:
 - 2.1 Provide the school with monthly price list,
 - 2.2 Buy all recyclables agreed upon at current market prices,
 - 2.3 Pay the amount of recyclables based on agreed schedule of payment.
 - 2.4 Bale, bundle and package the materials;

Section 4.Role of Selected Implementing School:

- In collaboration with the selected Local Government Unit (Tigbauan, Iloilo), shall develop and submit a Work and Financial Plan for the activities that will be conducted which shall form part of this gareement:
- Provide overall supervision in the implementation of the NEP and Designate a Project Coordinator to monitor the Project implementation thru the Municipal Environment and Natural Resources:
- Conduct information, education and communication campaigns among students, School officials, faculty and other support staff;
- 4. Document the experiences in implementing the program focusing on lessons learned, best practices and recommendations in implementing the NEP with the assistance of the partner organizations:
- 5. Establish the system of collection, storage and sale of recyclables;
- 6. Organize pupils/students onto an Eco-savers' Club;
- 7. Formulate policy on the setting up and management of the Eco-savers' Trust fund;

- Integrate the ecological solid waste management into the school curriculum;
- Submit quarterly reports to the LGU and copy furnish EMB thru the assigned Eco-Saver Coordinator
 of the Bureau;
- 10. Participate in project meetings and training activities;
- 11. Identify taker (junkshop/consolidator) of received recyclable materials;
- 12. Maintain a recording system of the materials.

Section 5. Joint Monitoring and Evaluation of Activities

The EMB Region VI, LGU of Tigbauan, Iloilo shall jointly monitor and evaluate activities conducted under this Agreement to ensure attainment of the set objectives.

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in Behalf of the Municipality of Tigbauan to Enter Into a Memorandum of Agreement with the Department of Environment and Natural Resources – Environmental Management Bureau (EMB), Region VI and Barroc Elementary School for the Implementation of National Eco-Savers Program (NEP) in Public Elementary and Secondary Schools in the Municipality of Tigbauan;
